RULES 1. This competition is open to all. 2. Each page musty be 8 ½ inches by 11 inches, unless approved by the Exhibit's Chair. 3. Exhibits must be specifically developed for this type of competition. For example, this must not be an unchanged part of a larger exhibit. 4. The entry fee of \$1.00 for either a One-Page or Four-Page exhibit, must accompany this form. 5. Entry Form and fees must be received no later than 6. Entrants are responsible for insuring their exhibits against loss, or deciding not to do so. 7. Exhibits must be personally delivered and removed from the Exhibit Hall by the owner or authorized agent. 8. Exhibits should be mounted on Thursday, November 12 between 6:30 and 8:30 pm. For Friday morning mounting, permission must be obtained from the Exhibit's Chair. All entry must be mounted by 9:45 am, Friday, November 13th. 9. Exhibits cannot be removed before 4:00 pm on Saturday, November November 14th. 10. All exhibits must go through the Exhibit's Chair for tracking purpose. 11. There will be a limit of 2 one-page and 2 four-page exhibits per exhibitor. This may be increased after the closing date if frames are not filled with 16 pages. 12. Exhibits will be judged made up a panel appointed by the Exhibit's Chair. 13. Judging Criteria: A. Does the title match the story? B. Is the emphasis of the exhibit on the philatelic material? C. Is the exhibit well laid out, eye-catching and fun to view? D. Is any hard to obtain philatelic material identified?
